

**AGREEMENT WITH BOOKSELLERS UNDER READERS CLUB SCHEME**

This agreement is made on \_\_\_\_\_ day of \_\_\_\_\_ 2018 at (Name of city) between M/s \_\_\_\_\_ (Phone: \_\_\_\_\_) (hereinafter called the bookseller) on the one part and National Book Foundation, National History & Literary Heritage Division, Government of Pakistan (hereinafter called the Foundation) on the other part.

2. Whereas the Foundation is implementing Readers Club scheme and Messrs M/s \_\_\_\_\_ (Phone: \_\_\_\_\_) are hereby registered as authorized bookseller subject to the deposit of **Rs.2000/= (Rupees Two Thousand only)** as registration fee for supply of books under the said scheme to the members of the Club at \_\_\_\_\_ for the year **2018-19** strictly as per conditions set forth in clause-3 of the agreement.

3. Now this agreement witnesseth as follows: -

- i) The bookseller shall supply the books to the Members of Readers Club (Name of City) at 50% discount on presentation of Readers Club Registration Card, in original, by the respective member in person, after proper identification.
- ii) Proper entry of books purchased shall be made in the membership card and credit vouchers (as per specimen attached herewith) by the bookseller without fail.
- iii) Signatures of the member on credit voucher must match with the specimen on his membership card.
- iv) The bookseller shall give uniform discount at the rate of 15% on all type of publications including the Holy Quran.
- v) The bookseller shall certify the genuineness of the price and that no book banned by the Government or a textbooks or an obscene/pornographic/anti religion/anti-state/anti-morality/sectarian violent literature/material, magazines/periodicals have been sold out to the members. The bookseller shall also ensure that any books precluded by the Club from time to time will not be sold out to the members. In case of any default the risk and responsibility shall be of the bookseller solely and that the Foundation shall not make any payment on that account in addition to legal proceedings, if any.
- vi) Ceiling of each member shall be checked properly by the bookseller before selling the books. Sale in excess of the ceiling will not be reimbursed.
- vii) On full utilization of the membership ceiling of **Rs.6000/= (Rupees Six Thousand only)**, the bookseller making final entry shall retain the card from the member and return it to the Foundation along-with credit voucher/bill.
- viii) The bookseller is required to ensure that the books written on the credit voucher and the membership card are the same, which have been actually purchased by the member. Any violation of the said moral and legal obligation, if detected and found, shall be attributed to the bookseller that may debar him from future registration.
- ix) If any malpractice is established on the part of the bookseller, the payment relating thereto shall be liable to be withheld and forfeited in favour of the Foundation, as a penalty. The bookseller shall also be liable to be blacklisted along-with cancellation of his registration.
- x) **A member can purchase maximum two copies of a title during a financial year. In case the bookseller sells more than two copies of a title to a member during a financial year, NBF shall not make payment of subsidy to the bookseller.**
- xi) The bookseller shall not make any cutting/over-writing on the credit voucher. Any cutting/over-writing must be verified by the member by signing the cutting/over-writing. Payment of unverified credit vouchers shall not be made
