I am directed to refer to NBF's letter No.269-HAD-67 dated 07-06-2024 and to state that the subject textbook was reviewed at NCC and subsequently a No Objection Certificate was issued for publication vide F.No.1-6(2023-NCCC/Dir/Urdu dated 07-08-2023 with the following terms and conditions:

- i) The NOC/approval is valid till the new curriculum is approved. However, the National Book Foundation will improve / update / revise any part or the whole textbook based on the feedback from the field during implementation and submit the improved version for NOC/approval
- ii) The textbooks are free from all biases related to cultural, ethnic, and / or linguistic differences of the people of Pakistan
- iii) There is nothing repugnant to Islam and its different schools of thought, Pakistan, and organs of the state in the textbooks
- iv) The National Book Foundation, before their large-scale printing and supply to schools, will ensure that the textbooks are free from all grammatical / punctuation / logical errors
- 2. In this regard, NBF is required to issue a corrigendum to all stakeholders on <u>Top Priority and the Most Urgent Basis</u> to avoid any untoward situation. The wording may be as under:
